#### **NOTIFICATION**

In partial supersession/modification of Rule 6 of Part 2, Chapter III, the Academic Council, WBUT, in its meeting held on 29.11.2013, in exercise of power conferred under Regulation 6.3 of Chapter II of Part 1 of WBUT First Regulations, is hereby pleased to frame the following rules which are not inconsistent and/or repugnant with the Academic Regulations under Chapter II Part 1 of the First Regulations governing academic and associated activities.

6 (Part 2, Chapter III – First Regulations, WBUT) Declaration of result, promotion and grading system:

#### 6.1 (Part 2, Chapter – III, First Regulations, WBUT)

In order to pass the B.Tech/B.Pharm/B.Arch/B.OPTM/BHM programme course a candidate must obtain at least D grades in each of the Theory, practical and Sessional items.

The promotional status shall be indicated on the even semester credit card/sheet as per details indicated in Part 2, Chapter I.

### 6.2 (Part 2, Chapter – III, First Regulations, WBUT)

- i. A student shall be eligible for promotion to the next higher level if he/she has cleared ALL course items of earlier semesters individually.
- ii. A student shall be eligible for promotion to the next higher level/year with backlogs provided such backlogs are to be cleared within the time limit specified for completion of the course, as prescribed under the First Regulations, WBUT.
- iii. Omitted
- iv. Has been a bona fide Regular student/Ex-student at the present level and is duly registered as such in the University and Institution under permission of the Director/Principal concerned.
- v. Has not been involved in breach of discipline or has not been time barred due to noncompletion of the course within the time limit fixed for the purpose.
- vi. Has not been temporarily suspended/suspended for a specified period by the University/institution and has not been denied the privileges of a Regular student/Exstudent at the time when admissions to higher levels is in progress.

These rules will come into force with effect from 01.01.2014.
