NOTIFICATION

Subject: Guidelines for admission in MCA Pragramme through decentralized Counseling (Institution Level) process for the academic year 2020-21.

Whereas, the necessary guidelines for admission to MCA Programme in the academic session 2020-21 through the State Level Common Entrance Examination for the said programme has already been notified and published by the West Bengal Joint Entrance Examinations Board.

And

Whereas, in the said guidelines, the West Bengal Joint Entrance Examinations Board has declared the necessary venue, period of counseling, application procedure, counseling fee, eligibility criteria, reservation policy as well as other relevant information towards admission to MCA programe in the academic session of 2020-21.

And

Whereas, in the said guidelines it has been mentioned that candidates will take admission to the allotted University and Institutes after obtaining allotment by the West Bengal Joint Entrance Examinations Board through the centralized counseling process;

And

Whereas, it has been observed that some seats are still vacant after the completion of such allotment and admission process in different participating Universities and Institutes of the State offering MCA programme.

And

Now, therefore, it is clarified that on completion of the centralized counseling and admission process, the participating Universities and Institutes of the State may pursue the admission procedure in the MCA Programme in the Universities and Institutes as notified hereunder:

a. For different participating Universities and Institutes, the eligibility criteria for admission through decentralized counseling process for MCA Programme shall be the same as notified in the guidelines issued by the West Bengal Joint Entrance Examinations Board.

- b. The participating Universities and Institutes willing to admit students through such decentralized counseling process shall have to follow a complete transparent admission procedure inviting application from eligible candidates by posting necessary Notice, declaring vacancy position in respect of the said MCA Programme, in their respective Notice Board and/or the Institution's website.
- c. The admission for such MCA Programme must be made strictly on the basis of merit and preference of candidate.
- d. Candidates have to follow the following norms as mentioned in the AICTE Approval Process Hand Book 2020-21:

Passed BCA/Bachelor Degree in Computer Science Engineering or equivalent degree

OR

Passed B.Sc./B.Com/B.A. with Mathematics at 10+2 Level or at Graduation Level (with additional bridge courses as per the norms of the concerned University) obtained at least 50% marks (45% marks in case of candidates belonging to reserved category) in the Qualifying Examination.

e. 2nd Year MCA Admission through Lateral Entry:

Lateral Entry to 2nd year degree course in MCA Programme shall be permissible up to a 10% of the "Approved Intake" which shall be over and above, supernumerary to the approved intake, plus the unfilled vacancies of the 1st year if any, as specified in the Approval Process Hand Book of AICTE:

Passed in BCA, B.Sc.(IT/Comp. Science) with Mathematics as course at 10+2 level or at the Graduation Level.

- i) Obtained at least 50% marks (45% in case of candidates belonging to Reserved Category) at the qualifying examination.
- f. The cut-off date for completion of the decentralized counseling and admission at the respective participating Universities and Institutes will have to follow he academic calendar of the concerned affiliating Universities for the academic year 2020-21.
