Sub: Supernumerary seats upto 20% over and above the affiliated intake per Non-AICTE course in respect of Non-AICTE Colleges for the Academic Session, 2025-2026.

Dear Sir/Madam,

You are aware that the introduction of supernumerary seats upto 20% over and above the affiliated intake per Non-AICTE course in respect of Non-AICTE Colleges affiliated to this University had been introduced in the academic year 2018-19 vide letter No. 2256/IC-234/2018 dated. 24/09/2018 and the same was in vogue in the academic years 2021-22, 2022-23, 2023-24 and 2024-25. **However, the said supernumerary seats upto 20% over and above the affiliated intake in respect of BBA and its specializations, BCA and BMS course is not applicable as those courses have come under the umbrella of AICTE from the Academic Year, 2024-25.** Furthermore, the provision of supernumerary seats had been incorporated under Clause 7 of the Information Brochure on Guidelines and Other Terms and Conditions of MAKAUT, WB (NON-AICTE) courses (2025-26) which had been notified vide letter No. IC-309/2024/3903 dated 14.11.2024. Without going through the said provision as mentioned under Clause 7 of the said guidelines a few colleges are asking for clarifications regarding the matter cited in the subject over the phone. It is once again made clear that **the said supernumerary seats over and above the affiliated intake per course except BBA and its specializations, BCA and BMS course will stand in force in the academic year, 2025-26 until further Notification.** For introduction of such supernumerary seats colleges are required to pay **Rs. 25,000/-** (Rupees Twenty-five Thousand only) per Non-AICTE course as affiliation related fee. During registration process of students under the said supernumerary seats the concerned colleges has to produce the receipt of the same of such fee to the Registrar, MAKAUT, WB.

This has got reference to the approval dated 16.10.2025 of the Competent Authority in File No. IC-309/2024.
