 - (iii) Flex to be designed for the competition for display in the main entrance and also a backgrounder for the final programme to be held on 29th April, 2022 for judging the posters, handing over the prizes to the 1st to 3rd position from UG & PG section respectively and participation certificates also to the students.
 - (iv) The programme to be attended by the Film Director Goutam Ghosh, Priyanka Malitha DSP (DEB), Nadia, Secretary District Legal Service Authority and Ms. Samapti Banerjee Resource Person & In-charge Centre of Training on Community Policing and Social Defence, Swami Vivekananda State Police Academy. Minutes of the Anti-Ragging Committee Meeting held on 6th April, 2022 in the Meeting Room at the Administrative Building of Haringhata Campus

The meeting of the Anti-Ragging Committee was called on 6.4.2022 to take a decision on the complaint lodged by a 2nd year student of Forensic Department named Sayan Sadhu. The meeting was attended by:

1. Prof. Raja Banerjee (Chairperson)
2. Prof. Indranil Mukherjee
3. Prof. Debashis De
4. Dr. Ranjita Biswas
5. Gargi Sengupta (Saha) (NGO: Madhyamgram Blaze Welfare Society)
6. Mir Rafiqul Alam (ASI Haringhata Police Station-Nominee of IC Haringhata PS)
7. Dr. Santanu Phadikar (Convenor-Antiragging Squad) – Invitee
8. Dr. Bratati Ghosh – Convenor

Complainant had lodged his application addressed to the Convenor Anti-Ragging Squad and to Registrar of the University where he had specified the names of four students (3 from CSE 3rd year B. Tech and one from IT 3rd year B. Tech).

Based on his complaint the Anti-Ragging Squad had held a meeting on 29.03.2022 and had in their resolution stated “The incident for which complaint made by Sayan Sadhu, 2nd year Student of B. Sc Forensic Science, appears to be true and it is learnt that Pijush Priyam & Subham Kumar of B. Tech CSE, 3rd year & Iftikar Ahmed, B. tech IT, 3rd year were involved in the incidents on multiple days. The matter may be sent to the anti ragging committee for further action”.

Further the Anti-Ragging Committee had in its meeting held on 6.4.2022 called the accused namely Pijush Priyam, Subham Kumar & Iftikar Ahmed and had taken their version also. They were made to narrate the incidents that took place and further representative from the Haringhata Police Station made them understand the veracity and the legalities involved in the act that has been committed by them and the consequence that could lead to ruin their future. They were asked to submit written submission.

Convenor, Anti-Ragging Squad Dr. Santanu Phadikar was invited to the meeting to explain his point of view.

The complainant had in his application mentioned that “These four boys along with few more came to me and started using foul language stating is this a park or OYO or a Red Light area, by seeing me with my friend when I said she is just my friend they started abusing me then few M. Tech seniors came and rescue me [Date 23/03/2022]”. Considering this fact, as he was not present in the campus, over phone he was asked to narrate the whole incidents that he has referred and exactly what took place with his friend and from his submission it was clear that his friend is from also 2nd year Forensic Department named Priyansri Chakraborty. Consequently Priyansri Chakraborty was also called to the meeting and after giving her a patient hearing she was asked to give a written submission.


As Sayan Sadhu was not available in the campus and in his complaint he has not narrated the incidents, so he was asked to email whatever he had stated over phone.

Considering the outcome of the whole meeting, the Anti-Ragging Committee unanimously resolved that:

- (i) The accused students based on their apology may be issued a strong warning that if they are found to be involved in any such activity which involves causing physical harm or damaging the integrity/ sovereignty of any student of the University in future then the University may be constraint to report the matter to the law enforcing authority and they will initiate necessary action as deemed fit. The said cautionary note may be issued with a copy to the HoD's of their respective departments. A hard copy may also be send to their Guardian/parents to their residential address but this matter may be left to the discretion of the University Authority considering the submission that the students have submitted.
- (ii) In the University main campus anti-ragging posters and flexes to be displayed at different junctures mentioning the composition of the Anti-Ragging Committee and also within campus and in the academic building and the hostels the consequences of ragging to be displayed more conspicuously. Digital display on the consequence of ragging to be started in the three academic buildings and also in the hostels. All these to be done with any further delay.
- (iii) A separate anti-ragging email antiragging@makautwb.ac.in to be generated for which Dr. Md. Aftabuddin to be requested.
- (iv) Convenor of Anti-ragging Squad to be included in the Anti-Ragging Committee as a Member.
- (v) Anti-ragging sensitization programme to be organized in intervals.
